Eligibility for each credit will be administered and processed separately. No bill credits will be issued to customers with Smart Thermostats that are not on the list of qualifying models displayed in section 3. Only the SCE customer whose name and address appears on the SCE account is eligible for this offer. Bill credit(s) will be issued to eligible customer approximately 6-8 weeks after successfully submitting the Application with a valid proof of purchase. Qualifying thermostats are those that are purchased on or after January 1, 2019. Qualifying thermostats purchased in 2018 may qualify for the \$75 Demand Response credit.
